Five proxies were submitted. Cindy Hanwell held a proxy from Jessica Hanwell. Mary Bailey held a proxy from Robert Frazier and from Michelle Cardene. Daria Messino held a proxy from Rachel Wright and one from Micheal Lamar.

According to the current By-Laws of the Shire, a quorum is defined as a minimum of three (3) officers or their deputies plus any other two (2) resident SCA members of voting age. As there were five (5) officers present and a total of twenty-one (21) resident SCA members of voting age in attendance, the Seneschal declared a quorum to be present.

## **Marshal Activities Reports**

### **Archery Company Captain (Tracey Hanwell)**

Winter practices have been scheduled for every other Wednesday and every other Saturday through April. The dates have been posted to the Shire calendar. I have already held some of these practices, and I have had three brand new people attend.

I am planning an Archery Opening Day tentatively to be held on May 9, 2020.

## **Committee Reports**

### **Blak Rose Yule**

Andrea Boyer reported that she has chosen people to work the gate and that Rachel Wright has agreed to do a thrown activity.

Frank Heilman stated that not much has happened. He plans to hold a committee meeting after this business meeting.

## **Old Business**

### **Calligraphy Demo Kit**

Tracey Hanwell reported that there is still one more item to be printed.

### **Sound System Proposals**

Tabled until the December 2019 meeting.

**Ballot Access**

*(Because a few members had not yet arrived, Tracey Hanwell asked for a suspension of order for this item. The suspension was granted by Daria Messino. This item was discussed after the New Business item Introduction to Camping.)*

Shawn Jones asked if anyone had received ballots. *(Chronicler's Note: The election timeline provided by Kingdom stated that ballots would be mailed on November 2, 2019. As of the meeting date, no one had received ballots.)* Elizabeth Dunhom stated that the ballots would be mailed by the end of the week. She claimed that the recent arrest of the King of the East delayed the election process.

Tracey Hanwell asked for a new election timeline with specific dates. Elizabeth Dunhom replied that she did not have that information and would forward it. Shawn Jones requested that the new timeline be forwarded to the Chronicler quickly.

Elena Daniel inquired of Elizabeth Dunhom if the candidates for office could get a list of all potential voters in the Shire so that the candidates could contact them. Elizabeth replied that the posted Letters of Intent are considered sufficient.

Some discussion took place about where the Letters were posted. Tracey Hanwell stated that they had been posted to the Shire's Yahoo group and Facebook Group. They could not be easily posted to the Shire's official web site because the Shire's forum was taken down by kingdom in June and the only current way to post the Letters was to hard-code them into the web page.

Lewis Wolkoff made a motion to designate Tracey Hanwell as the ad-hoc webminister and request that she be added to the ballots as a candidate for webminister. Andrea Boyer seconded and the motion passed unanimously. Tracey was directed to send in a Letter of Intent by the end of the day.

**Demo Proposal Procedures**

Tracey Hanwell reminded people that potential demos are supposed to be written up as a proposal and voted on at meetings.

**Bylaws Committee Proposal**

At the October 2019 Business Meeting, a motion was passed that the Bylaws Committee be formed according to the process outlined in our Shire's bylaws. Frank Heilman was directed to write a committee proposal accordingly. When asked for the proposal, Frank stated that there was no reason to discuss this.

**New Business****Persona Workshops**

Mary Braasch reported that she is working on these for a week night. She suggested a starting date of Tuesday, January 7, 2020, at 6:00 PM. There were no objections and some encouragement.

**Introduction to Camping**

Mark and Elena Daniel are planning a series of workshops for the spring. They are looking for a location where a fire pit exists or where a new one can be dug.

### **Yellow Breeches Demo Proposal**

Daria Messino handed out a proposal for a demo at the Yellow Breeches school. Andrea Boyer made a motion to table the proposal until a date was provided. Tracey Hanwell seconded the motion, which passed unanimously.

The proposal is attached at the end of these minutes.

### **Queen's Favors**

Lewis Wolkoff asked what the status of these was. It was reported by a Shire member that Amy McClintock is working on these.

### **Announcements**

The Bhakail Yule is scheduled for December 14, 2019.

### **Adjournment**

Daria Messino announced the meeting was adjourned; however, at this point Elizabeth Dunhom interrupted to make the following announcements.

Elizabeth stated that a group waiver form is required at all business meetings and noted that there was no form at this meeting. (*Please see addendum attached to these minutes.*)

Elizabeth apologized about the delay in sending out the election ballots.

Elizabeth stated that the bylaws committee was created at the direction of the previous kingdom Seneschal.

Elizabeth announced that the Blak Rose bylaws have been suspended by Kingdom. The Shire is now operating directly under kingdom law. Elizabeth stated that the proxy policy is "not healthy" for the group. She also stated that the entire grievances section will be removed. The Shire has six (6) months to make the changes to our bylaws that kingdom has demanded. A new bylaws outline is expected to be presented at the December business meeting.

Cindy Hanwell asked why the Shire bylaws were being suspended and by which Kingdom laws she was able to do this. Andrea Boyer also asked Elizabeth to state what laws allowed her to suspend our Shire's bylaws. Elizabeth stated that there were three areas of law that allowed this and that she would send them after the meeting. (*Please see addendum attached to these minutes.*)

Elizabeth stated that the reason Kingdom is suspending the Shire's bylaws is because the membership was using them to suspend the Kingdom's attempt to change our bylaws. She added that another reason the Shire's bylaws were suspended is because Blak Rose was giving the Kingdom "push-back." Cindy Hanwell asked if any other shires were having their bylaws suspended. Elizabeth said "no." When asked a second time by Cindy if there were any other shires that this was happening to, Elizabeth stated that Blak Rose was the only Shire that this was being done to.

Shawn Jones spoke out to say that any "push back" has come from a severe lack of transparency. Many Shire members had stated their wish (since July) to see the items that were requested to be changed. Elena Daniel asked "why not give us a list of issues kingdom has" and Andrea Boyer asked if Frank Heilman (appointed as the bylaws committee chair by Kingdom) was free to post the list to all the members. At this point, Elizabeth stated that Frank was free to

post the list to the membership, but soon after she stated that transparency would cause “too much confusion” for the committee and because of that they were advised not to make Kingdom’s comments available to all members of the Shire. When several members in attendance asked for the list of changes to be made public, both Frank and Elizabeth refused.

Shawn Jones stated that Kingdom has added to the difficult relations by its responses of becoming more and more authoritarian.

Elizabeth stated her intentions were not to be restrictive. She acknowledged Shawn’s statement and said the bylaws committee was given “direction, not restriction.”

Elena Daniel asked if there were parameters or a template of what the Kingdom wanted in bylaws. Elizabeth said there was no official outline or template of what was required to be in a shire’s bylaws listed anywhere.

Elena Daniel asked if she can ask questions directly of Adam Brennon (Special Deputy Seneschal overseeing this matter). Elizabeth said yes.

The discussion ended soon after and the meeting was adjourned at 3:08 PM. The next meeting will be held on Sunday, December 15, 2019, at the Linglestown Road Giant at 1:30 PM.

**East Kingdom External Letter of Intent (XLoI) dated 08-30-2019**

*Freydis in illa - New Name*

Now being decided; the decision should be known in February or March 2020.

**Laurel Activities**

The Wreath Sovereign at Arms

- Encouraged duty heralds who wish to wear the badge of their office to find ways which are appropriate to their time period and culture.
- Stated the following rules for allowing animate charges oriented in annulo as a step from period practice only if the following criteria are met:
  - There are a minimum of five charges in the charge group
  - The charges form the appearance of an annulet, either solid or broken
  - Each charge is independently recognizable in both type and posture
  - Animate charges which are attested in period to be in annulo singly, such as serpents and dragons, will continue to be registerable without a step from period practice.
- Clarified the rules on Non-Tergiant Reptilian and Amphibian Quadrupeds
- Stated the new rules regarding charges on tierces, gussets, and gores, as follows
  - Charged gores, charged gussets, and charged complex-line tierces are now allowed as a step from period practice.
  - Tierces with other charges directly on a field are no longer a step from period practice, due to period evidence supporting the practice.
  - Charged plain-line tierces are still disallowed, as they risk the appearance of marshalling. Charging an existing uncharged plain-line tierce as an augmentation will be allowed on a case-by-case basis.
- Commented on the use of memes like "Hail Hydrate."

**My Other Activities**

- I submitted my quarterly report to the East Kingdom College of Heraldry on November 6. It was late because I was in Israel on November 1.
- I continued to comment on names and armory at the Kingdom and Laurel levels.

## **SECTION I - When to fill out a Waiver**

- A. All persons attending SCA events must either present a membership card demonstrating proof that a signed waiver is on file at the SCA Member Services office (a "blue card", referred to as a "waiver card" in the SCA Governing Documents), or they must sign a waiver at the gate.
  - 1. An event, for the purposes of waivers only, pursuant to the SCA Corporate Policies, Section VI.C, is defined as any recreation function announced in the branch, Kingdom, or Principality newsletter. Further, any recreation function that is publicized in any other manner to the members of a branch, either local, Kingdom, or Principality, is also subject to the waiver policy. **Business meetings, demos, guild meetings, dance and other non-combative practices, or planning sessions are specifically excluded from these provisions (emphasis added).**

### **Elizabeth Dunhom's Reply to Andrea Boyer via email sent 11/21/2019**

**(regarding what law allows her to supsend the Shire bylaws)**

Greetings Sol,

As you have requested this information, here are the relevant document references.

Corpora: VII.A.4 "Local officers are responsible to a superior officer, and possibly Royalty, or a Territorial Baron and/or Baroness, depending on the particular administrative structure of that area.

EK Law IV.A.6. "Kingdom officers will supervise and coordinate the actions of their local counterparts throughout the East Kingdom."

IV.A.7 "Kingdom Officers have the authority to make policy for the discharge of their offices and their subordinates' duties, within the limits of their officers"

EK Seneschal's Handbook IV.G.1. The local seneschal must "read and uphold Kingdom Law and Corpora. Any question concerning the interpretation of Law can be clarified by the Kingdom Seneschal's office."

EK Seneschal's Handbook IV.G.20 "[Local seneschals] must make sure that all "local customs" are known to all branch members, preferably in written forms. While these "local customs" have no official standing within the hierarchy of rules governing the Society, they have a great deal of weight concerning the daily operation of local branches."
