Herald Report – 12/13/20 Eleazar ha-Levi - Deputy Herald

Laurel Activities (LoAR November 5, 2020)

- The "Mid Year Known World Heraldic and Scribal Symposium" will be held online on January 22nd to 24th 2021. Visit *kwhss.sca.org*/ for more information!
- The submission personal and group name rules regarding offensiveness by association have been changed and clarified. Names that reference places, persons, events or concepts that are morally repugnant to a large segment of the SCA or the general public will not be registered. The reference must be clear and unmistakable. When considering whether a name is offensive by association, any related armory that contributes to the appearance of offensiveness may be taken into account. The standard for offensiveness by association is high and each potentially offensive name element should be considered on a case-by-case basis. In such an analysis, the following factors should be considered: (1) the level of fame/infamy of the offensive association; (2) whether the name element is better known for things other than the offensive association; and (3) any other factors that suggest or refute offensiveness.
- A device with a bird other than an eagle displayed is no longer considered a step from Period practice.
- Having three objects in the same charge group be three separate tinctures is no longer considered a step from Period practice provided that the three objects are otherwise identical in type.

Laurel Activities (LoAR November 30, 2020)

- The new Pelican Sovereign of Arms, Viscontessa Elisabetta Tommaso di Carducci (also known as Elizabeth Turner de Carlisle, introduced herself. She officially took that office on October 1.
- The Palimpest Herald (rules keeper) has:
 - Ruled that name phrases that were only granted as an honor or award by rulers (for example, the Japanese title shinn{o-} means "Imperial prince" and was granted by the emperor to select male relatives beginning in the eighth century) cannot be registered. Such names are a claim to rank.
 - Has clarified the types of organizations that are considered household and listed the terms to be used to signify that they are households. This category includes guilds, military companies, and similar groups of people. Information on naming practices may be found at:
