Monthly Report

East Kingdom Internal Letter of Intent (ILoI) dated 04-19-20

I sent a letter to the Blue Tyger (Submissions) Herald asking why the name submissions for Ragnall Cennétig and Jonet Giffard and the device submission for Freydis in illa were not included in this ILoI. I got a letter back from Yehuda ben Moshe, Brigantia Principle Herald, saying that the Submissions Office was in the midst of a handover to a new Blue Tyger, and that this had caused some delays which he hoped would be fixed shortly.

- I attended (am attending) this year's Known World Heraldic and Scribal Symposium, held July 9-11 online in the Kingdom of the West.

Laurel Activities; Letter of Acceptance and Returns (LoAR) July 4, 2021

The Laurel Queen of Arms announced that bids will be accepted for 2022 Known World Heraldic and Scribal Symposium until July 1.

The Wreath Sovereign of Arms:

- Decreed that where grey proper against a light or dark background is concerned, it is to be interpreted as either sable or argent based whichever is most favorable to registration. That is, however, it best avoids both contrast issues and conflict.
- Ruled that all national arms and national flags are considered sufficiently significant to protect; except that flags that consist solely of one of the standard heraldic tinctures (argent, azure, gules, Or, purpure, vert, and sable) will not be protected.

The Pelican Sovereign of Arms ruled that names may now contain possible claims of superhuman abilities, magical powers, or divine origin if the name can be shown to have been used by humans in period. The name "Odinson" is acceptable because Odin was used as a Middle English and Norwegian given name during Period; however "Lokasson" is not acceptable because the base name "Loki" was only used to refer to the Norse god. Similarly, "Devil" appears as an English byname and is acceptable, while there is no record of a human named Beelzebub. The names "Warlock" (English byname), "Troll" (German), and "hálftr{o,}ll" (Old Norse: half-troll) were used by humans in Period and are now acceptable as name elements.
